

Exhibit 1. Please select which network or physician medical group you represent (n=22)¹








Exhibit 4. Does your network or medical group serve any of the following special populations? (n=22)⁴

Exhibit 5. Does your network or medical group provide behavioral health services? (n=22)






Exhibit 6. Does your network or medical group provide oral health services? (n=22)

Exhibit 7. What do you think are the top three social and economic problems that affect the health of Medi-Cal beneficiaries? $(n=22)^{5,6}$



Exhibit 8. In the following list, what do you think are the three most important health problems facing Medi-Cal beneficiaries? $(n=22)^{7,8,9}$





Exhibit 14. Do barriers vary by specific population or communities (e.g. children, older adults, refugees, immigrants)? (n=21)




Exhibit 15. If yes, please provide details about the barriers to accessing services that specific populations or communities might face $(n=8)^{16}$






