Documents for Medi-Cal Enrollment:

- Proof of California residency
- Household income (earned and unearned)
- Tax filing status (for everyone in your household)
 - O Note: additional verifications may be required if you are aged, blind, disabled, or if you are receiving Medicare

Documents for CalFresh Enrollment:

- Copy of your ID
- Proof of any income
- Proof of immigration status (for non-citizens)
- Proof of child support paid (optional but can increase benefit amount)
- If you are 60+ or disabled, proof of medical expenses (optional but can increase benefit amount)
