Quality Grant Program (Medi-Cal)

Goal:	<ul style="list-style-type: none">Utilize the unrealized funds from the MY2023 P4V Program to offer grant opportunities for quality improvement purposes.
High-Level Requirements*:	<ul style="list-style-type: none">Measures of focus must be from the MY2024 P4V Program (see subsequent slides).Applicants may submit grant applications for individual measures or groups of measures under each domain.A Health Network that performs below the DHCS MPL must submit a grant application for the measure below the MPL, as part of a corrective action plan.Grant amounts may range from \$50,000 to \$250,000 per measure/measure group.Grant funding is for a 1-year period.The number and amounts of grants awarded will be contingent upon available funds and determination of acceptable grants.Funds must be used to provide direct support to improve quality outcomes only for CalOptima Health members.

Quality Grant Application Process

- **Step 1:** Complete the Quality Grant Application Form for each program for which you are requesting a grant.
- **Step 2:** Ensure that the completed Quality Grant Application Form addresses the following components:
 - Total grant request from CalOptima Health
 - Measures of focus
 - Project scope / program overview
 - Planned interventions and utilization of evidence-based or best practices
 - Incorporation of quality improvement methodologies such as PDSA
 - At least one measurable outcome for each measure of focus
 - A sustainability plan.
- **Step 3:** Include an itemized budget for the project.
- **Step 4:** Submit requested documentation to the Quality Analytics Team at qualitygrants@caloptima.org prior to the application deadline.
- **Step 5:** CalOptima Health staff will review your proposal and reply to your request per the application timeline within the NOFO.

1 CalOptima Health Core Mission and Value Alignment	10	<ul style="list-style-type: none"> Project aligns with the CalOptima Health mission, vision, and values statements. Proposed program demonstrates value to the CalOptima Health membership and the Medi-Cal program.
2 Proposed Program Design	20	<ul style="list-style-type: none"> The proposed program is in alignment with the goals and objectives of the grant program as outlined in the Notice of Funding Opportunity. The proposed program is clearly described and addresses measures from the MY2024 P4V Program. The proposed program includes innovative, evidence-based practices or interventions that aim to significantly increase quality measure performance within the funding period. The proposed program incorporates quality improvement methodologies such as PDSA cycles or Six Sigma principles. Programs that positively impact multiple quality measures are preferred.
3 Project Implementation Plan & Measurable Outcomes	20	<ul style="list-style-type: none"> Provides a clear and complete implementation plan with well-defined project milestones and timeframes. Measurements are objective, quantifiable, and based on scientific knowledge or clinical practice guidelines. Appropriate goals and/or benchmarks are included. Quantitative data analysis and identification of root causes are included. Re-measurement is conducted at appropriate intervals. Clearly indicates that the program will be up and running within 3 months of grant award.
4 Equity	20	<ul style="list-style-type: none"> Project demonstrates a commitment to advancing health equity. Project aims to address health disparities (e.g., reduce the non-compliance with mammography screenings for a group that is performing lower than another group).
5 Demonstration of Sufficient Staffing and Resources	10	<ul style="list-style-type: none"> An itemized budget is included and is aligned with the objectives and activities of the project. Resources will be used to provide direct support to improve quality outcomes for CalOptima Health Medi-Cal members only. Applicant has identified staff to participate on the project.
6 Organization Experience and Program Capacity	10	<ul style="list-style-type: none"> Applicant has demonstrated experience needed to perform the program. Applicant is a stable organization and has demonstrated capacity to perform the functions of the program.
7 Sustainability	10	<ul style="list-style-type: none"> Identifies potential funding sources for sustainability of the project/program after the end of the grant agreement.

Quality Grant Reporting Requirements

- Applicants must provide quarterly budget updates to CalOptima Health throughout the grant period.
- Applicants must also provide quarterly project progress reports that provide insight into the number of CalOptima Health members positively impacted for each measure of focus, or insight into the impact to the overall measure rate

Examples of Potential Programs or Projects

Hiring of staff to provide in-person or telehealth visits to members after emergency room visits or inpatient discharges.

Provide members with at-home testing for hemoglobin A1c or colorectal cancer screening.

Purchase lead testing machines and test strips to complete point-of-care blood lead testing for pediatric members.

Purchase fluoride varnish and train staff to complete point-of-care application of topical fluoride to members.

Create a call center or dedicated team to complete telephonic outreach to members to schedule needed services (e.g. a PCP visit, a mammogram, a lab appointment).

Funds must be used to provide direct support to improve quality outcomes for CalOptima Health Medi-Cal members only.

Common Questions

1. What is the expected number of awards and what is the budget floor or ceiling?

- The number and amounts of grants awarded will be contingent upon available funds and determination of acceptable grants. Grant amounts may range from \$50,000 to \$250,000 per measure/measure group.

2. Can an organization submit multiple applications?

- Yes, an organization can submit more than one proposal.

3. Will the grants require a grant agreement or a contract amendment?

- Yes, a grant agreement will be required. Applicants that are awarded grants will receive a grant agreement to initiate funding.

4. Is the sample budget template an obligatory document to use?

- No, the sample budget template serves as a guide. Applicants may utilize their own template / format as long as they provide an itemized budget that is aligned with the objectives and activities of the project.

5. Do we need to spend the grant funds during the first year?

- No, the grant funds do not need to be spent during the first year. However, the grant application must specify the amount and duration of the funds in detail. Monitoring reports must also provide updates on fund spend down. Grant funds must not overlap with future grants. For example, if a grant is approved for MY2023 funds, the same grant cannot be submitted for MY2024 funding, if available. In addition, sustainability should also specify how the provider / organization will sustain the program when grant funding is no longer available.

6. Will there be a Quality Improvement Grant Program for OneCare?

- Yes, we will be offering a Quality Improvement Grant Program for our OneCare membership. MY2023 performance for OneCare is finalized later in the year, thus we are planning to distribute the Notice of Funding Opportunity in October 2024.

7. **Are the grant materials available on the CalOptima Health website?**
 - We are in the process of posting the materials and will distribute the URL once finalized.
8. **If we have other pending CalOptima Health grant applications, would this exclude us from being able to apply for this additional grant opportunity?**
 - No, having other existing grant contracts or pending grants for other notice of funding opportunities does not exclude you from being able to apply to this Quality Improvement NOFO, as long as your current CalOptima Health grants / contracts are in good standing.
